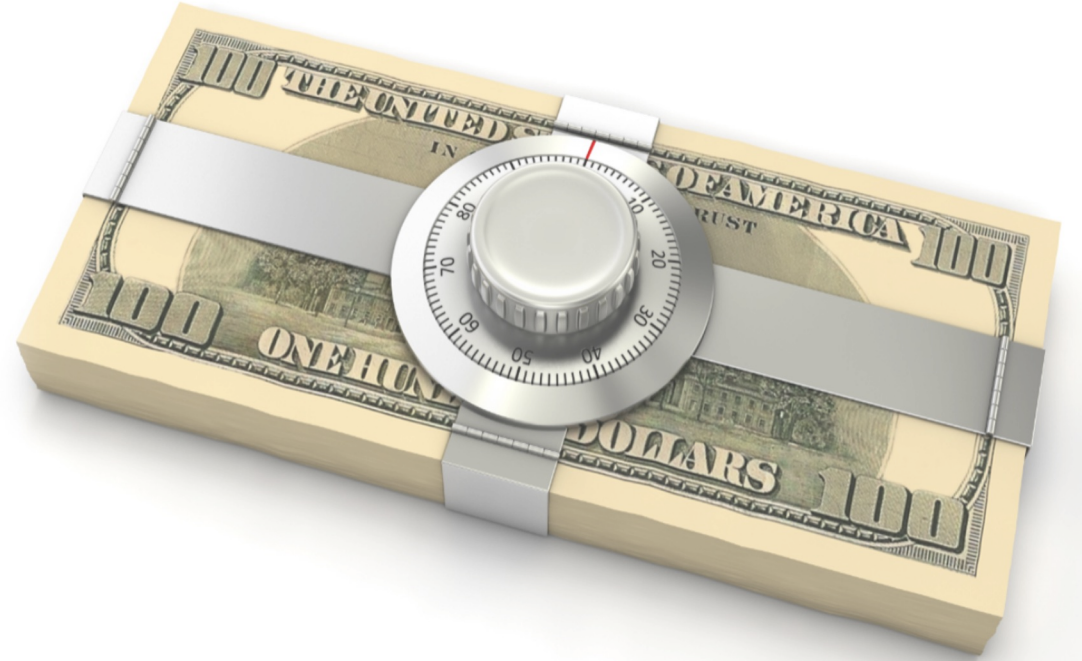

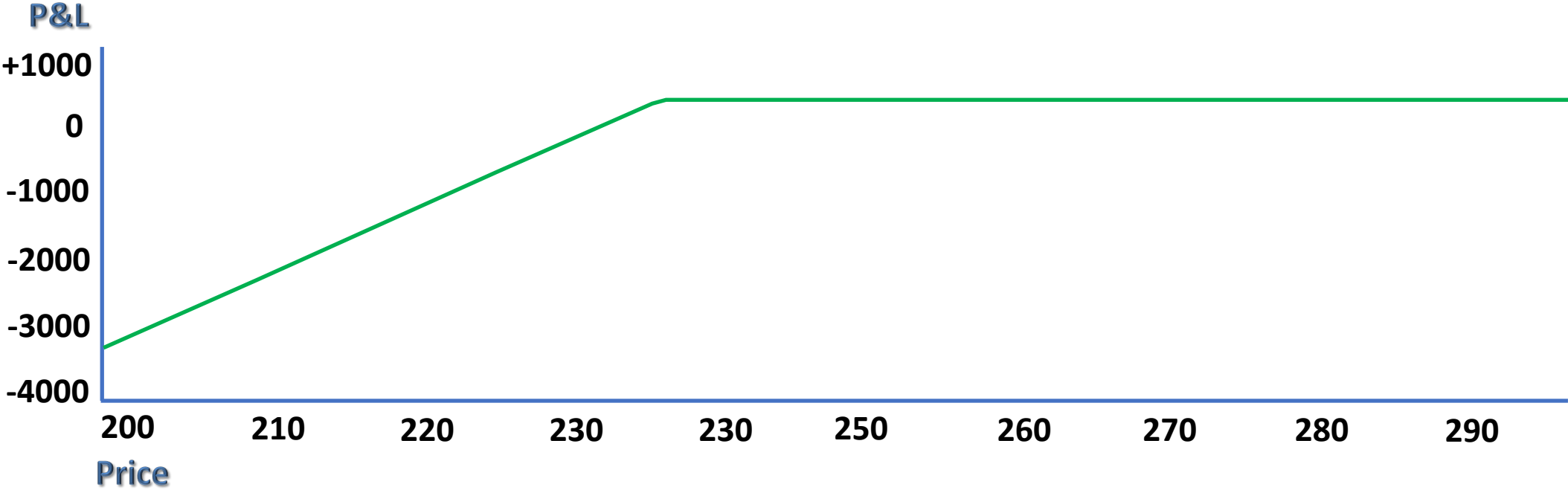

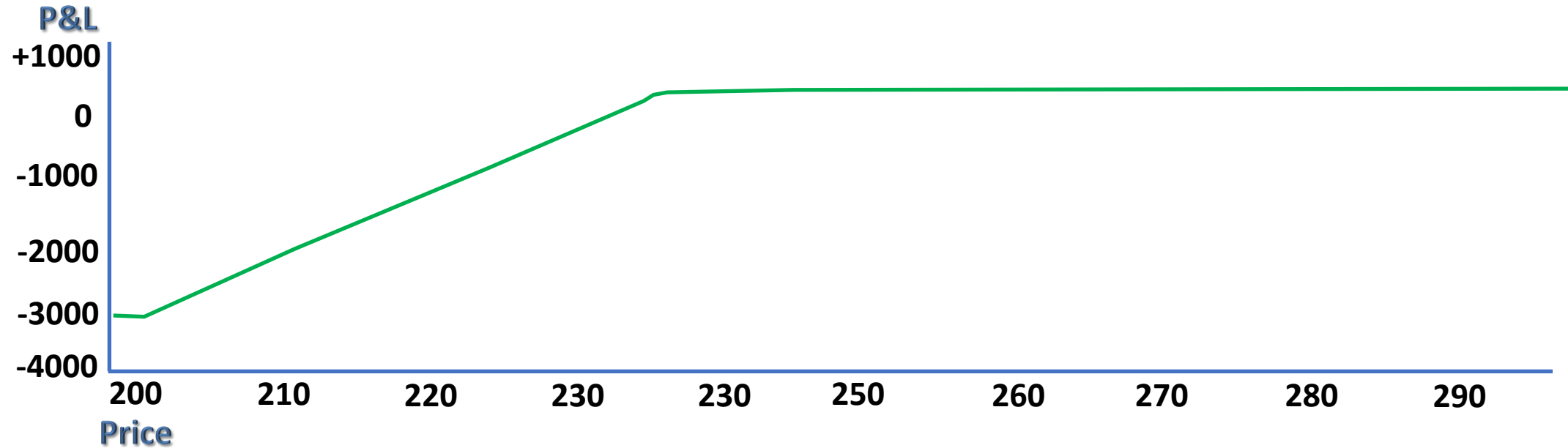
XYZ Cash Secured Put Example with price at 255

Sell 1 July 15th 235 Put - Buy 1 July 15th 200 Put for a \$3.25 Credit - Margin: \$3,175
