Brief History

- Eurex launched daily PM settled Euro Stoxx 50[®] (SX5E) options on August 28, 2023
- Acceptance has been on par with comparable US markets (S&P 500, Nasdaq-100, Russell 2000)
- On almost every trading day there are four consecutive daily PM expirations

- At-the-money (ATM) SX5E straddle pricing was recorded for settlements one to four days in the future
- The pricing is determined by using the mid-point of the bid-ask spread
- Each ATM straddle is exited based on holding through settlement
- For analysis purposes 2.00 points are subtracted from each execution to allow for slippage

Methods

For each time frame the following data is analyzed and broken out by month:

- Straddle pricing as a % of index
- Subsequent price change for index
- Profit / Loss based on buying / selling short incorporating 2.00 slippage



Combining With Long Straddle
